TMX is pleased to announce the successful launch and production availability of its enhanced pre-trade risk management and connectivity solution - a flexible platform offered in partnership with ULLINK, a global provider of market leading trading solutions.

The TMX Risk Management Service (RMS) offers a comprehensive suite of pre-trade risk controls to help equity trading customers achieve compliance with the complex Canadian regulatory environment, while operating within demanding performance and latency constraints. The TMX RMS enables participants to apply a variety of risk checks, trading limits and controls to their order flow, and offers real-time monitoring of overall committed capital, open order exposure and intraday market risk exposure across all major Canadian equity venues.

The TMX RMS provides customers with pre-trade risk-filtered access and connectivity to:

- (i) all TMX equity marketplaces via a single access point;
- (ii) away lit and dark venues via a dedicated access point; or
- (iii) all protected equity marketplaces via the TMX Smart Order Router.

The TMX Connectivity Service utilizes TMX RMS' efficient and integrated connectivity infrastructure without the application of pre-trade risk controls, thus offering a new means of connectivity to TMX equity trading venues. Customers can now access Toronto Stock Exchange, TSX Venture Exchange, TMX Select and Alpha through a single session, through which orders are routed by the TMX Connectivity Service to the applicable marketplace destination.

Order entry to the TMX Risk Management and Connectivity Service is in FIX 4.2 protocol, and is fully compatible with Quantum and Quantum XA trading systems. The platform is hosted in TMX's co-location facility, and is fully managed by TMX.
