## MARKET MAKING ON TSX



Many issuers have questions about the trading of their securities and, specifically, how the concept of “market makers” works. Each company listed on Toronto Stock Exchange (TSX) has a designated market maker firm and registered trader who is responsible for supporting an orderly market. Their role is to support liquidity and ensure a 2-sided market: buyers and sellers for each viable transaction. They augment organic liquidity, rather than creating artificial liquidity.

TSX has 17 dedicated market making firms representing over 115 individual market makers who have history and experience making markets in Canada dating back to the 1960s. They play a positive role in supporting the market each trading day. In periods of extreme market volatility and the most challenging market conditions, TSX Market Makers expertly buffer market activity.

Securities listed on TSX Venture Exchange (TSXV) are supported by Odd Lot Dealers, which are designed specifically for the junior market. For firms that would benefit from more traditional market making support, there is a policy in place that allows for private arrangements. This option enables venture companies to elect for those services, without imposing costs on those who do not need or desire market making.

## GET TO KNOW YOUR EXCHANGE

Companies listed on TSX and TSXV raised \$57 billion on the Exchanges last year and, since the start of 2012, more capital has been raised by these companies than by those listed on stock exchanges in London, Germany, Tokyo, Shanghai or Australia.

Companies in Canada and around the world leverage TSX & TSXV to raise important growth capital. Over the last 4 years, Canada ranks 3rd in the world by total equity capital raised and Canada is the leading country in the world for equity capital raised by population.

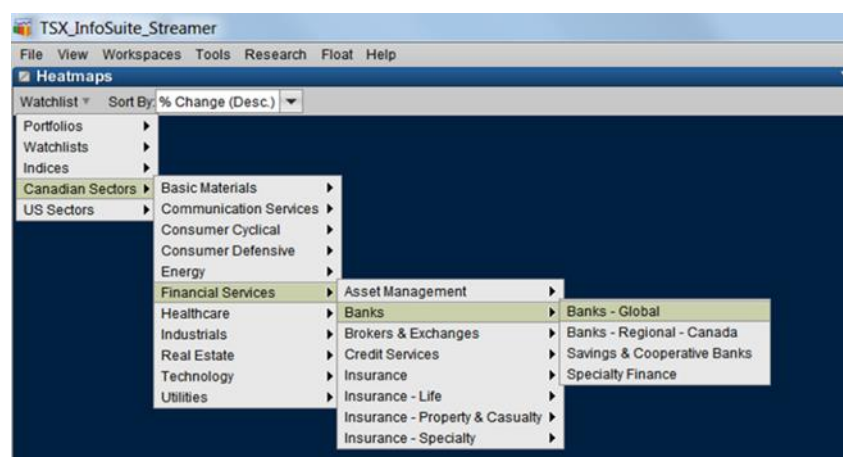
# TSX INFOSUITE: HEATMAP YOUR PEERS



TSX InfoSuite provides our clients with a wide variety of data and functionality, including an insightful "Heatmap" module which illustrates intra-day performance of peers, index constituents or portfolio investments. The module is available through the Streamer portion of TSX InfoSuite.

To run the Heatmap module, simply use the pull down menu to to:

1. Select an existing portfolio (or create a new portfolio in the Portfolio Manager)
2. Select an index
3. Select sector constituents
