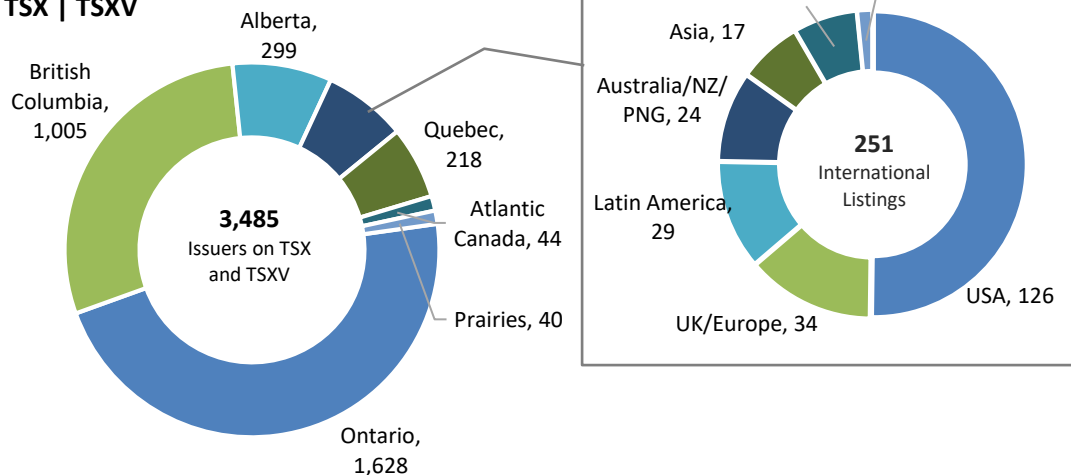

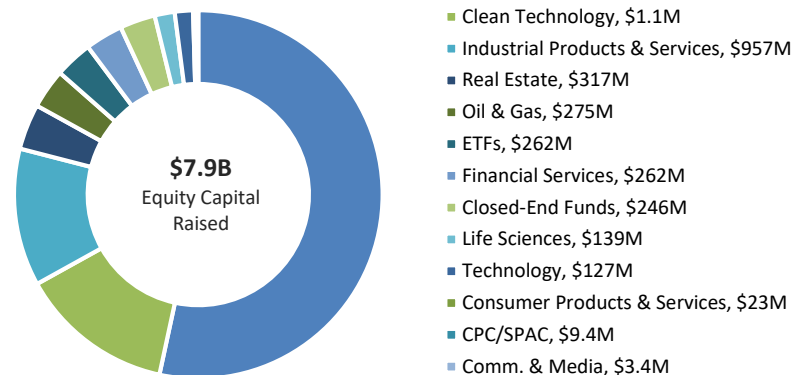

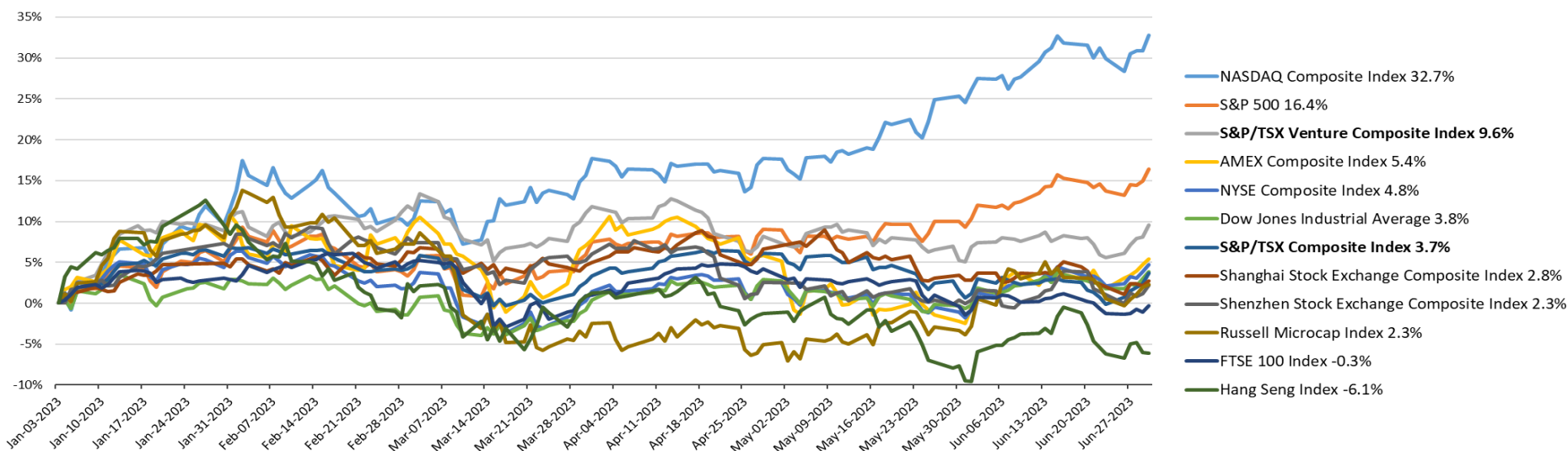

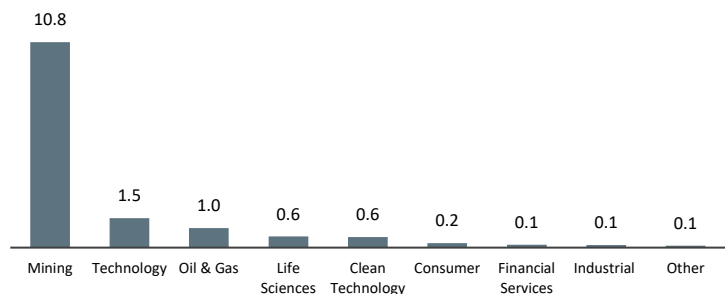
Major Global Index Performance -- YTD June 2023 (Source: S&P Capital IQ)



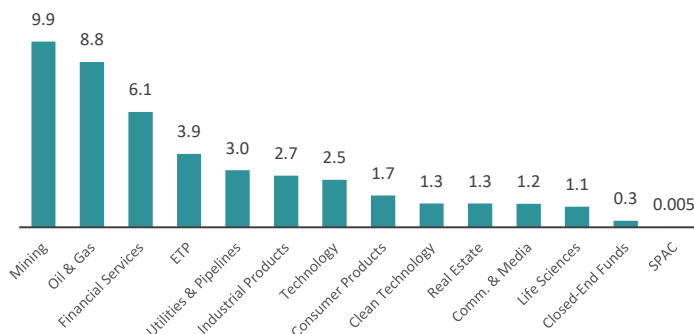
