**Re: Payment of Outstanding TSX Venture Exchange Annual Sustaining Fees and Payment Options**

### **SUSTAINING FEES**

This Bulletin is to remind TSX Venture Exchange Issuers that the 2024 annual sustaining fees were due and payable **March 31, 2024**. Please be advised that late payment can result in a late payment fee and that failure to make payment by **April 30, 2024** may result in the Exchange proceeding to halt the Issuer's securities.

If trading is halted, Issuers will be subject to additional fees. Please refer to Policy 1.3 for further information regarding the late payment fee. If payment is still not made following the halt, the Issuer may be suspended, resulting in a reinstatement review and potentially additional fees.
