Q2 2025 Highlights

The second quarter of 2025 demonstrated the market's resilience, transforming early volatility from U.S. tariff announcements on April 2 into record highs for the S&P/TSX Composite and S&P 500.

This renewed confidence fueled record-breaking net flows into Canadian ETFs, as investors strategically reallocated capital into these vehicles. Current momentum positions us to surpass 2024's annual record before Q3 concludes, with fixed income and international equity ETFs emerging as top destinations.

This influx of capital was met by unprecedented product innovation, with Q2 setting a new annual record for ETF launches. The 71 new ETFs from 20 different ETF issuers included both expansions of existing product lines and novel solutions designed for more sophisticated investment strategies.

Most notably, LongPoint ETFs and BetaPro broke new ground, launching the first 2X and 3X leveraged and inverse ETFs denominated in Canadian dollars and eliminating the need for cross-border trading. In parallel, issuers including 3iQ, CI Global Asset Management, Evolve ETFs, and Purpose Investments launched North America's first Solana and Ripple/XRP spot ETFs.




ETF Options Average Daily Volume and Open Interest
