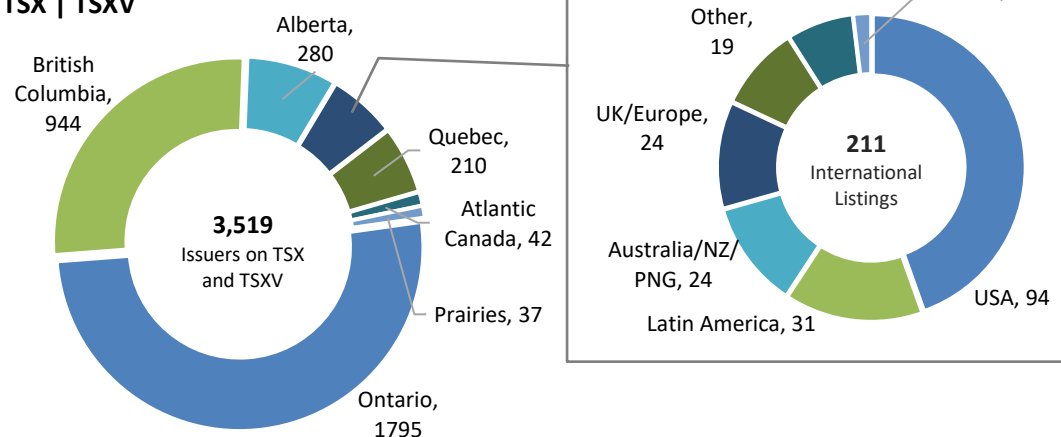

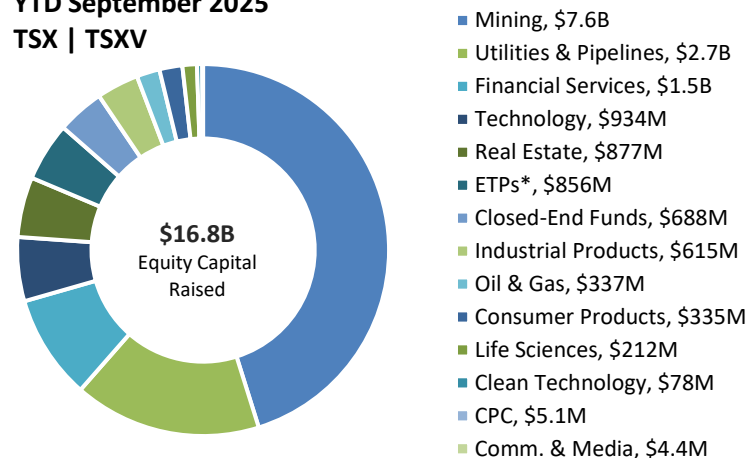
Listed Companies by HQ Location As at September 30, 2025 TSX | TSXV

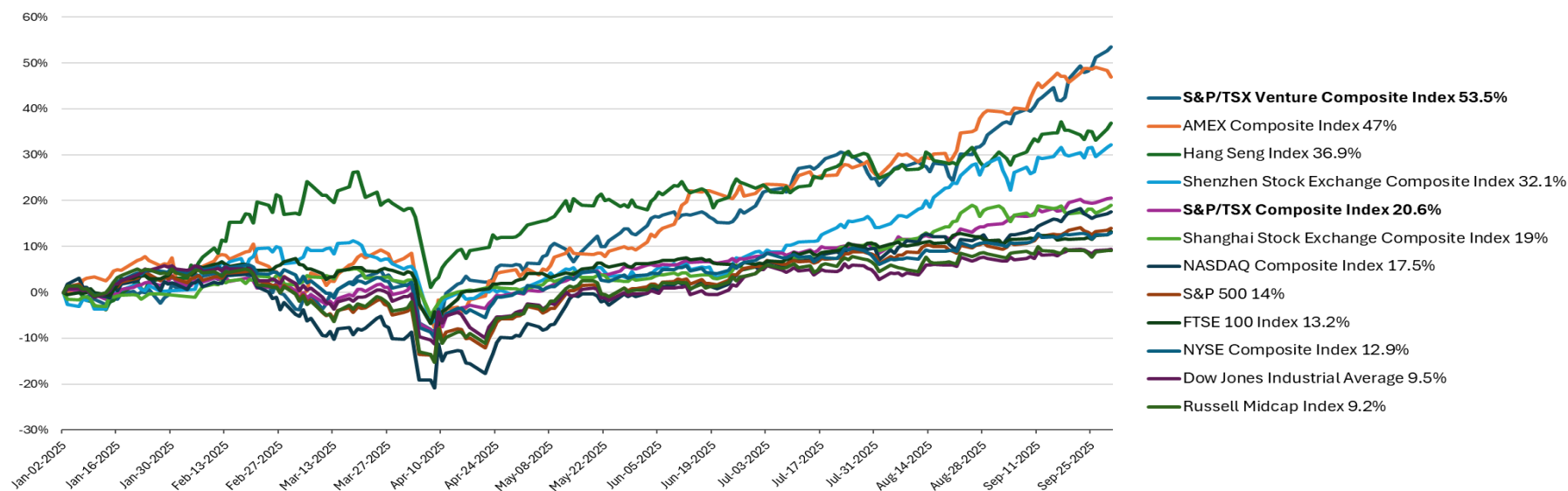
Equity Capital Raised by Sector YTD September 2025 TSX | TSXV

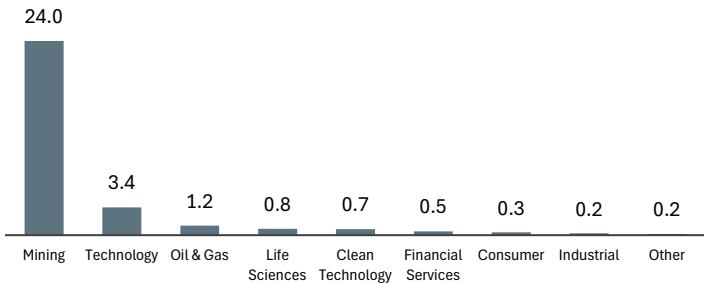

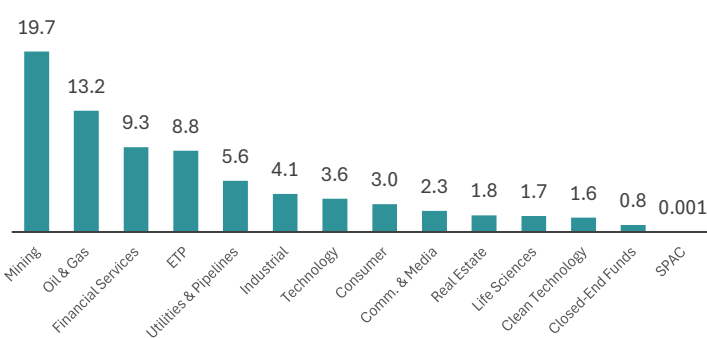
Volume Traded YTD September 2025 on TSXV by Sector (Billions of Shares)
