Q4 Recap

The final months of 2025 capped off another unprecedented year of ETF growth and new listings. ETF net inflows reached a grand total of **\$125 billion** in 2025, representing a 64% jump from 2024, according to the latest report from National Bank Capital Markets. The S&P/TSX Composite Index outperformed major markets around the world, delivering a **28.24%** return for the year.

This quarter set new records across numerous asset classes:

- **Equities:** While markets endured the [longest U.S. Government shutdown in history](#), stocks still ended the year on a rally. Canadian equities outpaced the U.S. with the S&P/TSX Composite Index and S&P 500 advancing 5.6% and 2.4% this quarter, respectively.
- **Materials:** Precious metals shined brighter than ever - particularly gold and silver. Unsurprisingly, metals and mining ETFs dominated the year, accounting for 8 of the 10 best-performing funds according to [Morningstar](#).
- **Fixed Income:** Amid more rate cuts from the U.S. Federal Reserve and Bank of Canada, the fixed income category posted 54% higher inflows year-over-year, National Bank Capital Markets reported. As inflationary pressures and geopolitical tensions persist, investors have increasingly turned to these ETFs to navigate an uncertain economic landscape.
- **Crypto:** Bitcoin hit another all-time high of [\\$126K USD in October](#) before declining again to close out the year.

In Q4 alone, issuers brought **45 new ETFs** to TSX, pushing our total number of ETFs to **1,239**. Among those launches, we celebrated new Single Stock, Asset Allocation, and Fixed Income offerings. TSX also welcomed **three new issuers**, Capstone, Rocklinc, and Tru.X to the ETF industry!

Lastly, we hosted in-person programming across the country, joining forces with our ETF partners to reach retail advisors, financial institutions, and industry professionals:


- **Fall Lunch & Learn Series:** We conducted 10 panels across 5 major Canadian cities, connecting 25+ ETF issuers directly to brokers in these key markets.
- **14th Annual TSX Institutional ETF Conference:** Over 100 attendees joined us in the TMX Market Centre, bringing together the Canadian ETF industry and institutional investors, and providing a vital platform for thought leadership.

From record-breaking growth in assets to the engagement at TSX events, this past quarter was a testament to the strength of the Canadian ETF community. We're kicking off 2026 with momentum, and a number of launches are already underway - thank you for your continued trust and partnership.




MX ETF Option Trading Overview


ETF Options Average Daily Volume and Open Interest
