Temporary MOC Eligibility for Constituents of the S&P/TSX Small Cap Index

In response to client demand, effective Thursday September 15th 2011, during the annual S&P/TSX Small Cap Index rebalancing period all current and recently added constituents of the S&P/TSX Small Cap Index will be eligible for the Market on Close (MOC) facility.

The MOC facility currently includes all constituents of the S&P/TSX Composite the S&P/TSX Global Gold Index and the S&P/TSX Global Mining Index as well as certain symbols that are MOC eligible based on participant demand and feedback. As a result, the following symbols that are not MOC eligible will become MOC eligible for this period effective Thursday, September 15th, 2011.
