### Alpha Migration to TMX Quantum<sup>™</sup> Update

TMX Group is pleased to provide additional information related to the migration of Alpha to TMX Quantum. Previously published information related to the migration can be found in PO Notice 2012-046 and PO Notice 2012-050.

Details on the Alpha migration plan are provided below.

#### **Scheduled Key Dates**

#### GTE Testing for Alpha

- The test environment will be available February 19, 2013.
- TMX Alpha order entry and feed specifications are available through the TMX Equity Markets Documentation Portal at <a href="http://tmx.com/en/login.html">http://tmx.com/en/login.html</a>. Please note that Alpha will not support the EMAPI protocol effective April 29, 2013.
- Existing session bundles to the TMX Quantum gateway can be used to access Alpha.
- A formal certification will not be required for those currently certified to the TMX Quantum Gateway. Note that one new value in the existing ExDest Tag will be required for orders that are intended to be routed to Alpha.
- Although not mandatory we encourage all clients to test and validate access to TMX Alpha via FIX and/or STAMP.

#### **Technical Launch**

- To facilitate client connectivity and routing testing/validation prior to the migration, test symbols will be enabled in the Alpha production environment on TMX Quantum upon Technical Launch on April 1, 2013. The test symbols are not intended for performance testing.
- All market data multicast feeds will be permissioned for the purpose of validation/testing in the production environment.

#### Alpha on TMX Quantum Production Launch

- Effective at the close of business on Friday, April 26th, all open orders on the existing Alpha platform will be purged.
- No open orders will be transferred as part of the migration.
- Effective Monday, April 29th, Alpha will operate on TMX Quantum at its new location in the existing TMX Group data centres.
- Effective Monday, April 29th, Alpha will have the regular pre-open session commencing at 7:00 a.m. At that time, clients will have the opportunity to re-enter orders.
- The following two weekends have been designated as contingency migration dates if required.

#### Alpha Market Data Feeds

All existing Alpha data feeds will cease to be available after the migration to Alpha on TMX Quantum. The following Alpha data feeds will be available effective April 29, 2013:

ABF - Alpha Broadcast Feed (Level 2 with encrypted private and public data, STAMP protocol) ARF – Alpha Reconciliation Feed (encrypted private and public data, STAMP protocol)

AL1 - Alpha Level 1 Trades and Quotes (QRTMD Feed fixed file format)

AL2 - Alpha Level 2 Orders and Trades (QRTMD Feed STAMP protocol)

AQL1 - Alpha TMX QuantumFeed Level 1 (XMT protocol binary format)

AQL2 - Alpha TMX QuantumFeed Level 2 (XMT protocol binary format)
